## NURS 301: Transitions

As the first course for RNs who are pursuing a baccalaureate degree, this course provides an overview of the evolution of nursing as a profession. Students are oriented to the role of being scholar-clinicians. The course supports an evolving professional identity and examines major issues and trends in contemporary nursing. Students will explore critical abilities in professional practice such as effective communication, working in groups, teaching-learning, and more. The prevailing focus of analysis is quality and safety for the care of individuals, groups, and families. This course is a prerequisite for all other courses in the nursing major for RN-BSN students.

8. Explain communication and effective group processes as critical elements in the practice arena as well as in the role of scholar/student.
9. Implement the essentials of evidence-based nursing practice in baccalaureate study, using the virtual library as primary resource to support studies and ultimately, the competency of an evidence-based contemporary practice.
10. Recognize the attributes of professional nursing practice while clarifying values specifically related to baccalaureate education and practice.
