This course will introduce students to mystery and detective fiction as a literary genre and as popular literature, examining the conventions of suspense writing, possibly including hook, twist, red herring, back story, sub-plot, procedural, clues, and the ethical concerns of investigative methods and civic life.

Discussion of various sub-genre styles will engage students in critical thinking applied to historical era, culturally diverse contexts, and gender roles in mystery writing.

C. OUTLINE OF MAJOR CONTENT AREAS

1. Within the genre, students will read short stories and novels, watch films, and apply critical thinking to the ethics in the fictional depiction of law enforcement, civic life, cultural diversity, historical contexts, and gender roles in mystery writing. Students will be required to produce written responses.

Apply critical thinking to historical and diverse cultural contexts, including how historical era affects the plot; how roles of gender and sexual orientation work in the texts; what mystical or supernatural aspects impact the storyline; how diverse cultures shape the story. 5. Carefully and thoughtfully analyze mystery and detective literature in regard to ethical concerns. (MnTC G2, comps. a, b, c, d; MnTC 9, comps. a, b, c; Program Goal 3a, 4)
6. Reflect, with depth, on civic life and responsibility in the fictional depiction of crime and law enforcement. . (MnTC G2, comps. a, b, c, d; MnTC 9, comps. a, b, c; Program Goal 3a)
7. Critique film adaptations of mystery and detective novels. (MnTC G6, comps. a, b, c; Program Goal 1, 2b)
8. Relate the background of mystery and detective authors to their craft. (MnTC G6, comps. a, b, c, e; Program Goal 1, 2b)
